* Fiscal year 2007 ridership reflects both boarding increases and adjustments. The natural monthly increase for Routes 202, 206, and 208 ranged from 3% to 94%, and Route 204 declined 7%. For January 2006, the monthly ridership for the Commuter Link routes were unaccounted by approximately 4% to 30%. The natural YTD increases for Routes 202, 206, and 208 ranged from 17% to 64%, and Route 204 declined about 6%. For July 2005 to January 2006, the YTD ridership for the Commuter Link routes were unaccounted by approximately 8% to 36%.
