* Fiscal year 2007 ridership reflects both boarding increases and adjustments. The natural monthly increase for Routes 204, 206, and 208 ranged from 17% to 35%, and Route 202 declined 3%. For May 2006, the monthly ridership for the Commuter Link routes were unaccounted by approximately 3% to 31%. The natural YTD increases for Routes 202, 206, and 208 ranged from 11% to 63%, and Route 204 declined about 5%. For July 2005 to May 2006, the YTD ridership for the Commuter Link routes were unaccounted by approximately 7% to 35%.
